SAP ERP Fundamentals (FI/CO/MM/SD modules)

COURSE OVERVIEW

This foundational course gives an introduction to the core functional modules of the SAP ERP system, offering a deep dive into the integrated business processes that form the backbone of modern enterprises. - The organizational structure elements (Company Code, Plant, Purchasing Organization, etc.) that form the framework of an SAP system.
- The key master data objects, including Customer, Vendor, Material, and General Ledger Master Records.
- The complete Procure-to-Pay (P2P) cycle, from purchase requisition to invoice verification and payment.
- The complete Order-to-Cash (O2C) cycle, from sales order creation to billing and accounts receivable.
- How financial postings are automatically generated in FI from transactions in SD (sales) and MM (procurement).
- The fundamental concepts of Management Accounting in the CO module, such as Cost Centers and Internal Orders.
